

Community Connection

Elizabeth Etouke Member, Frederick County Advisory Board Graduate/Doctoral Student





We are grateful to Elizabeth Etouke for sharing her inspirational story during **National Poverty in America Awareness Month**. Elizabeth beautifully describes her journey as a single mother and immigrant from Cameroon to doctoral student in her graduation speech linked below. Read on to learn how her lived experience will guide her doctoral thesis and beyond. Congratulations, Elizabeth, on your achievements and good luck as you continue to pursue your dreams!

Good morning and Happy New Year 2025! My name is Elizabeth Etouke, and I am pursuing a doctorate in public administration while working as a Data Analyst for the State of Maryland. My personal experiences with financial instability, especially as a single mother relying on Temporary Assistance for Needy Families (TANF), have profoundly shaped my passion for public administration. Public programs became a lifeline for my family and highlighted the importance of effective public service, motivating me to improve such programs.

As a former participant in the Temporary Cash Assistance (TCA) program, I faced challenges balancing work with the pursuit of a meaningful education. This experience will guide my doctoral thesis on Temporary Assistance for Needy Families. I aim to address the question:

"How can TANF be restructured to better support economic mobility for singleparent households while reducing dependency on government aid?"

Key focus areas will include: revising work requirements to prioritize education and skills training; expanding access to affordable childcare and healthcare; and creating pathways to stable, high-paying jobs. My research will highlight and evaluate the barriers faced by single-parent households through qualitative interviews or surveys while providing areas of improvement to alleviate these barriers and facilitate better program outcomes. The second question in my research will be:

"What innovative policy changes could enhance the effectiveness of the Temporary Assistance for Needy Families (TANF) program in addressing intergenerational poverty?"

This question addresses the issue of poverty that spans generations and highlights TANF's potential role in breaking the cycle. Key focus areas will include integrating TANF with educational initiatives for parents and children, developing mentorship and family counseling programs, and incorporating mental health services. I am interested in implementing pilot programs to evaluate the long-term outcomes of TANF recipients through longitudinal studies.

One aspect of my dissertation is the contrast between the Social Security program for seniors and the TANF program. Social security is often seen as more dignified, while TANF's name suggests poverty and lacks aspiration. I believe renaming it to something like "Temporary Assistance for <u>Rising Families</u>" could improve its perception.

Hopefully, after this dissertation, a national reform of the TANF program could be initiated, and I would hope to be part of that implementation.
